# **NEW PLAN GOVERNANCE**

On April 1, 2013, the Public Service Superannuation Plan Trustee Inc. (PSSPTI) became the Trustee for your pension plan, the Public Service Superannuation Plan (the "Plan"). The PSSPTI is responsible for the overall management of the Plan and makes key decisions in the best interest of all Plan beneficiaries.

The PSSPTI is comprised of directors representing both employees and employers. This includes representation from the NSGEU, CUPE Local 1867, non-union employees, retirees and the Nova Scotia Government

Day-to-day investment management and administration of the Plan is delegated to the Nova Scotia Pension Services Corporation.

The 2013 Canada Savings Bonds (CSB) Payroll Savings Program campaign runs until November 1st.


The CSB Payroll Savings Program is a great way to save for short and long-term goals. It allows you to contribute to a savings plan through automatic deductions from your pension payment. You can contribute as little as \$2 per week and your funds are guaranteed by the Government of Canada.

### **HOW THE BRIDGE BENEFIT WORKS:**



Your Public Service Superannuation Plan pension is made up of two parts:

- 1. The Lifetime Pension, 1.3%, is payable from the date you started receiving your pension until death, and
- 2. The Bridge Benefit, 0.7%, is payable from the date you started receiving your pension <u>until age 65</u> (even if you began receiving your CPP benefit prior to age 65).

### **RETURNING TO WORK?**

If you are returning to work with an employer who participates in the Plan, please contact us to determine if your pension payment will be affected.

Did you know?

- Under the *Income Tax Act*, you are not allowed to contribute to and collect from the same pension plan at the same time.
- Under the Income Tax Act, pension plan contributions must cease no later than December 1st of the year in which a plan member becomes 71 years old.
