We are currently recruiting for Equipment Operators. If you are flexible, possess experience operating heavy equipment, and are seeking an opportunity to directly contribute to the safety of our roads and highways, we want to hear from you.

#### **About Our Opportunity**

Weather in Nova Scotia is challenging and ever changing. As an Equipment Operator, your role is pivotal in helping the public arrive safely to their destination.

During the Summer Works Period, this position is primarily responsible for operating summer maintenance equipment such as trucks, tractors, graders and loaders. Some of this equipment will also have various attachments for maintenance activities. General maintenance of the equipment, pre-and-post trip inspections, and completion of daily logs is also required. Throughout the year and depending on provincial needs, you will also be required to assist with construction and maintenance work such as:

- Maintaining traffic control signs;
- Road surface repairs;
- General maintenance; and
- Traffic control.

#### **About You**

To be eligible, applicants must be declared competent as an OPTP (One Person Truck Plow) operator by the Department of Transportation and Infrastructure Renewal.

As the ideal candidate, you are flexible, self-motivated, and comfortable working in adverse weather conditions. As part of our team, you bring professionalism and hold a high standard for client service.

Knowledge of hydraulic systems and a mechanical aptitude are considered assets. Previous experience working with asphalt, patching and paving will be considered assets.
