# TRAINING/TESTING

**Equipment Operator – Excavator & Tag Trailer** 

Under Article 14 of the Collective Agreement between the Nova Scotia Department of Transportation and Infrastructure Renewal and the Canadian Union of Public Employees, Local 1867, the following training/testing opportunity is being posted:

LOCATION: Pictou County - Zone 10 & 11

WORK GROUP: Group III

POSITION: Highway Worker / Equipment Operator

TRAINING OPPORTUNITY: Excavator & Tag Trailer

NUMBER TO BE TRAINED: Four (4) - One (1) per Base

POSTING DATE: April 19, 2024

CLOSING DATE: May 3, 2024 at 4:30 pm

### **Qualifications:**

- Applicants must have been declared competent as an OPTP Operator by TIR within one year of this posting.
- Applicants must pass the Department of Transportation and Infrastructure Renewal operator examination administered by an EQII as defined in Article 14.03 to be deemed qualified to operate or eligible for training for excavator & tag trailer.
- Knowledge of the pre-trip inspection program and equipment servicing procedures is required.
- Knowledge of the department's Health, Safety and Environment Program is required.

The successful applicant(s) will work under the Operations Supervisor, carry out excavator & tag trailer operations on provincial highways and adhere to established Safe Work Practices and Job Procedures, including but not limited to excavator & tag trailer operations. Load securement training will be offered to all applicants by an EQII prior to testing.

Bargaining Unit Members, who have completed a probationary period, are currently working in the applicable maintenance zone and meet the posted qualifications will be considered first in the selection process for training opportunities by date of seniority.

Applicants shall be subject to a screening process in the form of testing and/or interviews to verify qualifications, physical abilities and mechanical aptitude. This shall be completed by resources inside or outside the Department. The successful applicant(s) will be tested on an excavator equipped with an industry standard excavator control system with ditching and/or trenching bucket to shape, trench, ditch, load and unload various construction materials and establish proper slopes and grades to provide proper drainage.

Applicants must pass the Department of Transportation and Infrastructure Renewal operator examination administered by an EQII as defined in Article 14.03 to be deemed qualified to operate or eligible for training for excavator & tag trailer operations.

In accordance with Article 14.03 at the end of the training and or testing process, employees who are deemed qualified are expected to operate the equipment when required.
