Qualifications:

- Applicants must meet all admission requirements for the Commercial Safety College Straight Truck Program.
- Applicants must have a Class 5 driver's license with air brake endorsement.
- Knowledge of the pre-trip inspection program and equipment servicing procedures is required.
- Knowledge of the Department's Health, Safety and Environment Program is required.
- Applicants will also be required to achieve Fitness for Work standards which meet Class I medical requirements.

The successful applicant(s) will attend the Commercial Safety College Straight Truck Program. Following successful completion of the program the successful applicant will return to their current position at their current work location. The applicant may periodically carry out equipment operations with eligible equipment on provincial highways and adhere to established Safe Work Practices and Job Procedures, including but not limited to equipment operations. A return to service agreement is required as well as a strong desire to become a winter equipment operator in the future.

Applicants must pass the Department of Public Works operator examination administered by an EQII as defined in Article 14.03 to be deemed qualified to operate equipment or to be eligible for training on equipment.
